



# HIHEALTH HERDCARE CATTLE HEALTH SCHEME

## Separate Herds Declaration



A herd is defined as cattle that are under a unified management system but not necessarily on one site. All cattle on the holding are considered to be part of the herd except under exceptional circumstances where the herd's owner and veterinary surgeon can show that adequate separation of the two sets of animals exists and can be maintained to satisfy the rules of the scheme. ### Declaration by Owner/Manager

The herds are managed separately. There is no shared grazing between the herds and manure from one herd is only spread on the corresponding fields. Any shared equipment, transport and handling facilities are thoroughly cleansed and disinfected before transfer between herds. The herds are housed separately (i.e. have separate air spaces when housed). Appropriate quarantine periods and testing are carried out for any movement of cattle between herds (i.e. they are treated as 'added animals' under CHeCS rules).
